LEGISLATIVE REPORT

2/21/2010

This is budget crunch time at the Capital, and all eyes are focused on that process as both the House and Senate must report their versions of the state's new two-year budget tomorrow. There are really four versions of a proposed state budget to consider: one presented by outgoing Governor Tim Kaine; proposals by newly-elected Governor Bob McDonnell, and the versions determined this weekend by the House and Senate. As the complex process continues through the session, the House and Senate will each pass their own version of a new budget and reject the other body's version, forcing a committee of conference consisting of a small group of representatives - call budget conferees - to meet between now and the final days of session in an effort to reconcile the differences. When that happens the legislators can go home and the Governor gets to take a final whack at the newly-passed budget. Any changes he makes, either in the form of amendments or vetoes, are considered in the April "veto session" of the General Assembly.

We continue to closely watch the legislation highlighted under *Transportation Funding* in Myles' report below. We are halfway through the session. So there is still lots of time for lots of things to happen, or not happen. In the area of transportation funding, VUHCC members need some things to happen!

Budget:

The House Appropriations and Senate Finance Committees released their respective budget documents on Sunday afternoon. Both budget documents featured significant cuts in education and health and human resources. As expected, both the House and

Senate decided to preserve the over \$950 million a year in car tax reimbursement to the localities. Both houses utilized alterations in the Virginia Retirement System (VRS) in an effort to bridge the hole in the state budget (the House's actions on VRS generate over \$803 million over the biennium, while the Senate's actions produce a one time general fund savings of \$508 million by partially deferring payments to VRS).

The Senate's budget embraces a number of new fees (many proposed by outgoing Governor Tim Kaine) to help generate extra revenues totaling over \$145 million. The Senate utilized these fees as well as a combination of balance transfers to mitigate deeper cuts in K-12 education and health and human resource spending. Late last week, Governor McDonnell suggested cuts in public education of approximately \$730 million over the biennium (the Senate settled on a reduction to public education of \$133 million). The reduction in Health and Human Resources was much more significant, totaling over \$344 million (although the Senate did preserve popular programs that subsidize health insurance for the children of the working poor, as well as funding for free clinics, community health centers and dental services for the underserved). Under the Senate spending plan, \$182 million is restored to support locally elected constitutional officers, along with \$20 million in support for local police. The Senate plan institutes three furlough days in each of the next two years, and would give state employees a 3% bonus in December 2011.

The House budget focused squarely on public education and health and human resources for reductions. House Appropriations Committee Chairman Lacey Putney (I-Bedford) noted that these two areas of the budget comprise two thirds of the general fund expenditures, yet they have largely been spared the deep budget cuts other areas of the budget have been subject to over the past several years. Consequently, the vast majority of the House's budget reductions come in the areas of public education (\$620 million over the biennium) and health and human resources (over \$325 million over the biennium). House Appropriations Committee members argue that the public education reductions are mitigated to a large extent due to the reduction local school districts will be required to contribute to employee pensions (a savings of \$270 million each year) and the elimination of a required secondary planning period for teachers that would save more than \$185 annually. The House budget actions will increase class sizes throughout the Commonwealth.

Unlike the Senate, the House chose to eliminate all the fee increases embedded in Governor Kaine's introduced budget, and they resisted any additional fee increases, which forced the House to institute deeper cuts in an effort to balance their budget. The House spending plan did restore deeper cuts to public safety recommended by Governor Tim Kaine. The House also refrained from further cuts in higher education (both approaches were strongly supported by Governor McDonnell).

Neither chamber chose to do much of anything for transportation in their respective budget documents. The only item of interest comes from the House. In an effort to save \$80 million over the biennium in general fund dollars used to support the Route 58 debt service, the House decided for the first time ever to swap general fund money for Tobacco Indemnification and Community Revitalization Commission (TICRC) dollars. The move will likely disturb members from Southside and Southwest Virginia, who utilize this tobacco money in large part for economic development related initiatives in these economically distressed regions of the Commonwealth.

It is interesting to note that the Senate Finance Committee voted overwhelmingly to approve the budget with only one Republican registering opposition. There was significant speculation that the Democratic majority would have difficulty maintaining unanimity in what had become very contentious budget discussions within the caucus centered on the deep cuts that would be required to balance the budget. It ended up that the disagreement and open rancor actually occurred in the House Appropriations Committee, where all but one House Democrat voted to reject the House budget (this is the first time in several budget cycles that the Democratic members of the Appropriations Committee voted en masse against the budget). It appears that the action within the Committee will set up a partisan showdown on the floor of the House. Regardless of the House Democrats opposition, it appears that the House Republicans will be voting in block to pass the Appropriations Committee's budget.

School Funding Issue:

Both the House and Senate budgets support Governor Bob McDonnell's recommendation to unfreeze the local composite index (LCI), which determines state funding for K-12 education. In unfreezing the LCI, which will provide additional funding for many jurisdictions in Northern Virginia, both chambers decided to also provide "hold harmless" payments that would limit the adverse fiscal impact to school districts in southwest Virginia, Hampton Roads and the Richmond area.

Legislation of Interest:

Of the 2,649 bills introduced during the 2010 General Assembly Session, approximately half of the bills have been defeated or carried over until next year. Of the measures still alive, the following might be of interest to the Council:

Transportation Funding:

There are currently two bills that would provide additional revenues for transportation that are still moving their way through the legislative process. SB 343 sponsored by Senator Emmett Hanger (R-Augusta County) would re-index the gas tax every year to

correspond with increases in the fuel efficiency of motor vehicles as determined by the Corporate Average Fuel Economy (CAFÉ) standards for fuel efficiency in cars. The proposal would take the percentage increase in the CAFÉ standard each year and multiply it by the 17.5 cents-per-gallon gas tax in Virginia. Assuming that fuel efficiency standards continue to go up each year, the tax paid on each gallon of gas would increase as well. The Department of Taxation estimates that the measure would generate an additional \$11.6 million in 2011, and could increase to \$85 million in 2012. By 2014, it is estimated to bring in nearly \$198 million. The Senate endorsed the measure on a 31-9 vote. However, the bill will next be considered by the House Finance Committee, which is dominated by conservative, anti-tax Republicans, who are likely to view SB 343 as a tax increase.

Senate Minority Leader Tommy Norment (R-James City County) is the sponsor of SB 513, which would authorize wagering on videos of previously run horse races. This “historical horse racing” bill would generate \$80 million annually, with \$33 million going to transportation. The bill passed the Senate on a vote of 25-14. The bill has passed the Senate on several occasions, only to be blocked by the House General Laws Committee. Speaker of the House Bill Howell (R-Stafford County) is vehemently opposed to the bill, which will likely make passage of this measure difficult at best.

Electronic Work Verification Program:

HB 737, which is sponsored by Delegate Dave Albo (R-Fairfax County) and requires E-verify to be used by state and local governments in hiring new employees, was passed by the House on a 82-13 vote this past week. The measure will now be considered by the Senate Commerce and Labor Committee, which is the same committee that refused to support another E-verify bill patroned by Senator George Barker (D-Fairfax County) (it is worth noting that Senator Barker’s bill was much broader than the one that will be considered by the committee in the next week or two). The Appropriations Committee has also put language in the House budget that mirrors HB 737. Consequently, if Delegate Albo’s bill is defeated in the Senate, the language embedded in the House budget would still need to be rejected by the House and Senate budget conferees. If the budget language is included in the conference committee report, E-verify will be required to be utilized by state and local governments.
